Suicide is not a new idea The Bible records seven suicides: 1 Abimelech (Judges 9:52-54) - he lacked personal identity 2 Samson (Judges 16:25-30) - he died for a cause he believed in and for revenge 3 Saul (1 Samuel 31:4) - he felt rejection, humiliation, and fear 4 Saul's armor-bearer (1 Samuel 31:5) - he wanted to die with his boss
